Municipal Judge Jim Casey met with City Clerk Amy Phillips on April 17, 2015, for the purpose of examining the election returns of the Regular Municipal Election held on April 7, 2015.

**CERTIFICATE OF ELECTION RETURNS**

I, Amy Phillips, City Clerk, do hereby certify that the attached is a true and exact copy of the Abstract of Votes Cast at the Regular Municipal Election held on April 7, 2015, to elect two City Councilors and to asked the eligible voters of the City of Durango Question 1-A. The two candidates receiving the most votes were declared as having been elected to terms of (4) four-years. Question 1-A EXTENSION OF THE EXPIRATION DATE OF 1999 ONE-HALF OF ONE PERCENT SALES AND USE TAX.

WITHOUT RAISING THE RATE OF ANY TAX OR IMPOSING ANY NEW TAX, SHALL THE EXPIRATION DATE OF THE CITY'S EXISTING ONE-HALF OF ONE PERCENT SALES AND USE TAX APPROVED IN 1999 BE EXTENDED TO DECEMBER 31, 2039; AND SHALL ANY REVENUES REMAINING AFTER THE REPAYMENT OF THE BONDS AUTHORIZED IN THE 1999 ELECTION BE USED TO FUND THE COSTS OF THE CONSTRUCTION, OPERATIONS OR MAINTENANCE OF RECREATION FACILITIES, PARKS, TRAILS, PEDESTRIAN AND BICYCLE IMPROVEMENTS, MAINTENANCE FACILITIES USED BY THE PARKS AND RECREATION DEPARTMENT, AND THE URBAN FOREST; WITH ALL EXPENDITURES BASED ON THE RECOMMENDATIONS OF A CITIZENS ADVISORY BOARD TO THE CITY COUNCIL AND SUBJECT TO AN ANNUAL AUDIT?

Said results have been ascertained, determined, and certified in accordance with the requirements of the Charter of the City of Durango and the Statutes of the State of Colorado.

In accordance with the Abstract of Votes, Dick White, having received 1,974 votes and Sweetie Anita Marbury receiving 1,938 votes were hereby certified as the candidates elected to hold four-year terms on the Durango City Council. Question 1-A passed receiving 2,725 votes cast in favor of, and 1197 votes cast in opposition. Total ballots cast was 3,954; and the total number of ballots issued was 10,323.
