

# City of Durango Restaurant Delivery Fee Reimbursement

#### Program purpose:

In response to the severe economic hardships resulting from the COVID-19 pandemic, the City of Durango is launching the City of Durango Delivery Reimbursement program. The City of Durango will offer reimbursement to restaurants where delivery fees exceed 15% for the period starting December 1, 2020 and ending January 31, 2021.

#### **Objectives and Eligibility:**

The program will initially allocate up to \$40,000. This program does not guarantee the City's financial assistance.

- Retain and support city businesses that have been negatively affected by the disruption of services during the COVID-19 crises, to include:
  - Assist businesses in maintaining or increasing their current workforce.
  - o Assist in reopening businesses.
  - o Prevention of additional business closures.
  - Funding necessary to make reasonable and temporary accommodations to comply with a Public Health Order.

## **Required Documents**

- On monthly basis restaurants shall submit the following:
  - Reports from the delivery vendor that reflecting the transactions and the amounts being requested for reimbursement in the excess of 15%
  - Documentation showing the restaurant or food establishment has paid these fees (bank statements correlating with the amount of fee)
  - o Reimbursement will be for small businesses as designated by the SBA.
- Documents could include:
  - Bank statements
  - Proof of payment to delivery vendor
  - Reports showing the amount charged over 15%



## City of Durango Business Delivery Fee Reimbursement

To be eligible for grant assistance, small business applicants must demonstrate a need for assistance resulting from COVID-19. Applications must be for reimbursement of fees exceeding 15 percent December 1, 2020 through January 31, 2021. Applications will be accepted through February 28, 2021. Qualifying applicants must provide documentation regarding the following components:
